

HOUSING OUTREACH PROGRAM...

- 2,730 residents contacted
- 105 residents received service
- \$233,148 in total Investment

Paint Rebate Program:

- 9 homes painted
- \$6,285 in reimbursements made to low- and moderate-income homeowners to paint the exterior of their homes
- \$18,992 total invested into painting homes (including owners' share for labor)
- \$3,359 credit extended through the Revolving Loan Fund

Dominion East Ohio Housewarming Program:

- · 31 homes received energy efficiency upgrades (insulation, electrical, furnace)
- \$191,843 total in weatherization, energy, and mechanical upgrades
- Average of \$6,188 invested per house

Contractor Referral Guide:

- 613 contractor evaluations mailed to homeowners who closed building permits in 2012

- 411 contractor evaluations compiled to-date


Partnership with Neighborhood Housing Services of Greater Cleveland:




