LakewoodAlive administers a Housing Outreach Program which connects residents with resources to maintain and sustain the community's historic housing stock and ensure healthy and safe living environments. These connections are made through:

- · Working one-on-one with residents, primarily lowmoderate income residents, to connect them to financial and educational resources as well as volunteer labor to complete necessary home repairs.
- The Paint Lakewood Program which is a grant reimbursement program for low-moderate income residents to assist with exterior house painting. The program is designed to offer a sliding-scale grant to provide financial assistance to make exterior house painting more affordable and attainable.
- Knowing Your Home educational series, which is focused on best sustainability and home maintenance practices empowering homeowners to tackle necessary home repairs and improvements. These workshops are offered to all residents at no cost.
- Provide a contractor referral guide for residents to view peer comments about contractors based on their experiences.
- Partner with the City of Lakewood and the Municipal Court and other organizations to assist residents with code compliance and Housing Court violations.
- Connection to local social service agencies that provide safety net services to make sure that our residents are being taken care of both inside and outside of their

The services that are provided through the Housing Outreach Program are designed to offer a one-stop place for residents. both owners occupants and renters to gain access to services so that they are able to live in healthy and safe housing. Through these programs we are able to help maintain vibrant neighborhoods one home at a time.


