HOUSING OUTREACH PROGRAM

2018 ANNUAL REPORT

LakewoodAlive administers a Housing Outreach Program which connects residents with resources to maintain the community's aging housing stock. These services are designed to offer a one-stop place for residents to ensure they are able to live in healthy and safe housing:

- Working one-on-one with primarily low-moderate income residents to connect them to resources, as well as to volunteer labor to complete necessary home repairs.
- The Paint Lakewood Program, a grant program for low-moderate income residents to assist with obtaining affordable exterior house painting.
- Knowing Your Home educational series, which focuses on best sustainability and maintenance practices empowering homeowners to tackle necessary home repairs and improvements. These workshops are free to attend.
- The Community Engagement Program in the eastern end neighborhoods seeks to improve the quality of life for residents through neighborhood-wide events, door-knocking and one-on-one appointments.
- Volunteer Project Program which connects low-income senior citizens and community residents to volunteer groups looking to give back to create vibrant neighborhoods.


