Paint Lakewood Program Guidelines

This program will provide a reimbursement up to \$4,500** to City of Lakewood homeowners and residents for exterior paint, supplies, and labor to paint your home. The goal is to revitalize and improve Lakewood's neighborhoods and reduce lead hazards by educating residents on lead safety issues.

Applicants must:

- Live or own property in Lakewood, OH
- Meet income guidelines (see below)
- Apply & be approved prior to painting—no receipts or invoices dated prior to approval will be accepted
- Complete painting within 90 days of project start
- Paint entire exterior of home based upon allowable painting surfaces
- Become familiar with lead safe paint practices prior to painting prep work. Information & training provided by LakewoodAlive at the property (EPA Requirement)
- Have property inspected 3 times by LakewoodAlive
 1. Prior to approval
 2. After all prep work completed but before actual painting begins
 3. After work is completed
